# JOHN SHIRLEY of STAUNTON HAROLD


John Shirley, esq. the eldest son of Francis Shirley, was born at Staunton Harold in 1535 and "in his youth instructed," as we are assured by his grandson Sir Thomas Shirley, "in all manner of good literature, virtue, and military discipline, by the most know ing and excellent masters of his time, in which he profitted so much, that he drew admiration from all that ever saw him, who all praised him for the sweet candour of his life, and rare acuteness of his wit."

In 1588 he married Jane, the only daughter of Thomas Astwell, in the county of Northampton, esq. By this alliance several manors came to the Shirleys,

viz. Astwell in the county of Northampton, South Newington in the county of Oxford, Dorsington in the county of Gloucester, and St. Botulph's Bridge in the county of Huntingdon.

### SONS

- 1. George who succeeded his grandfather as head of the family.
- 2. Ralph, intended for the Church, but died without taking orders. His name appears at the English College at Rome in the year 1582. He was of Stretton, in Staffordshire when his brother George granted him an annuity of 9 pounds out of the manor of Sileby, in Leicestershire. # RALPH SHIRLEY of ENGLAND

[the following is extracted from the Annual Letters of the England Mission for the year 1583].

Ralph Shirley died at the English College, Rome. He was born of respectable parents, who, after a long resistance to the Holy Spirit, was at last by the Grace of God brought over to the Catholic religion.

Having come to Rheims from England at the instigation of a Catholic kinsman, he was often solicited by Dr. Allen to join the true Church, and although he strove to reject these counsels with great obstinacy of mind, still they always left some sting conscience, which goaded him day and night so that failing to silence these, he gave himself up to pleasure, seeking by this means to distract his mind from unpleasant thoughts.

At last, apprehensive of being converted to the truth, he set off for Paris to meet an English gentleman, whom he took to be a heretic (for so he had been slyly persuaded by a Catholic), but finding that the person he was in search of belonged to the Society whose members he loathed as an omen of evil, he resolved in the heat of anger to go and visit Beza at Geneva. Providence, however, so contrived that, at the very time he wished to set out on his journey he was seized with a violent attack of fever, which obliged him to keep to his bed for several days; and during this time, being charitablly visited by an English gentleman and a priest, who was one of our Society, he was by them brought into the bosom of the Catholic Church, and having recovered from his illness, he resolved to give up all thought of Geneva and go on to Rome.

Meanwhile, letters were brought from a Protestant relation of the youth to the Queen's Ambassador, begging him either to keep the young man in Paris or to send him in safe custody to Geneva. This having come to the knowledge of a heretic who happened to meet the youth, and who found him already prepared to start for Rome, he endeavoured to detain him at all hazards. But, Shirley, seeing the great danger there was in delay, and thinking of no other way of setting himself free, drew his dagger and threatened to stab the other on the spot unless he desisted; then, putting spurs to his horse, he set


off for Rome at full speed.

After his reception into the English College, he gave remarkable proofs of every virture during the course of his life, and in his last illness.

His conversion he himself was wont to set down to the merits of St. Augustine, towards whom, even from his childhood, although bred and born among heretics, he had always felt moved with a special devotion.

- 3. John Shirley, entered Trinity College, Oxford, in April 1582. He was of the Inner Temple, as appears by a deed dated May 27, 1590, whereby he assigned to his brother George the site of the manor of Brailesford, and died in the wars in Flanders of a shot in the knee, received in the services of the King of Spain.
- 4. Thomas Shirley, enter ed Gloucester Hall, Oxford, Dec. 20, 1587. In 1591 he appears to have been in the service of the Earl of Essex. He was afterwards of Gray's Inn, and was living in 1602, as appears by a deed of January 16, 1602, whereby he released to his brother George lands in Brailesford upon the settling of Shirley upon him for a term of years. He died in England, s.p. His arms, quartered with Braose, were remaining in the south window of the hall of Gray's Inn in Dugdale's time.

Their son Philip is next in line to inherit Ettington.

# LOUGH FEA ESTATE

Lough Fea, the Lake of the Rushes, so called from the margin of rushes which fringe its shores, gives name to the manorial residence of the SHIRLEY family near the town of Carrickmacross in the Barony of Farney and County of Monaghan in Ireland.

The house is built on a rising ground, surrounded by well-wooded hill, in the Townland of Duehatty, or "The black town" not far from a place of some antiquity which had been in former times the seat of a gentleman's family, who held their lands under the Shirley Family, as "Middleman," a position no longer to be found on the Shirley Estate.

The building was begun by the late Evelyn John Shirley, Esq. in the year 1825. Its style is Elizabethan, selected as well-suited to the surrounding scenery, and to and estate granted by Queen Elizabeth to Walter Devereux, the first Earl of Essex, in the year 1576, the Husband of her cousin Lettice Knollys.

[Walter, Earl of Essex, married Lettice, daughter of Sir Francis Knollys, by Katherine, daughter of William, Lord Huntington, and Mary Boleyn, daughter of Thomas Boleyn, Earl of Wiltshire, sister of Queen Anne, the mother of Queen Elizabeth].

Lough Fea House is erected entirely of free-stone found on the Estate, and something after the manner of a College; on the right is the Great Hall, on the left the Chapel, in front the principal living rooms; over the entrance porch are the arms of Shirley with the quarterings of Basset of Drayton, Broase, Devereux, Platagenet, and Ferrers, and the date 1838.

The ceiling in the Library is taken from that of "The Brown Room" at Wiston in Sussex, the ancient seat of the Shirleys of that place.

Some of the Irish antiquities preserved in the Hall is a very large caldron or vessel made of six plates of beaten bronze, riveted together with pins, and ornamented with sharp points of the same metal, sixty inches in circumference at the widest part, by eleven and a half in height, which was discovered twelve feet below the surface of the Bog of Lisdromturk in the Barony of Farney, in the year 1834. Here also may be seen the standards of the Farney yeomanry of 1798.

Well...the story doesn't stop here! I called Ann and asked her to please send the copy of the will etc. She did and also enclosed the following letter written in 1951 to Ann's uncle Billy. At the time her uncle Billy or anyone else in the family had no idea what this gentleman was writing about.

The letter is written by REV.P.W.N.Shirley April 26, 1951. (He was an Archdeacon).

Dear Sir,

You and I are probably third or fourth cousins, and presuming on our kinship, I should be glad if you could give me some information about our family.

What I want to know particularly is the name of the Shirley who, towards the end of the 17 hundreds married as his second wife, the daughter of a Dublin lawyer. Also the lady's name (Christian and surname).

You are descended from the second marriage and I am the great grandson of the first marriage. My grandfather's name was Paul and the names I want particularly are my great grandfather's (father of Paul) and his two wives.

Garnaman, near Thomastown and Kells in Co. Kilkenny are descended of the Shirly who married the Dublin lady, and whose name, with her husband's, I want.

Garnaman, by the way, was Shirley property at one time, but it was not in possession of a Shirley for some years until it was bought by a Shirley (a descendant of the Knockabranna Shirley) who was Coroner of South Kilkenny and whose grandson lives there now.

What I am particularly interested in is the name of the husband of the Dublin lady and if possible the name of this man's father.

I shall be most grateful for any information you can give me.

I recently received a letter stating that
Mr. Shirley had passed away last year after they had become members. They still continue to be interested in our work and have not only renewed the membership but the son is now also a member.

I have written all involved and am hoping to hear if Ivan Shirley and the Shirleys at Garnaman House have met...or if they already know one another, etc. Now... this find helps Earle Shirley who had the ad under Ann Nosovs in the Dec. 1987 NEWS. He too has been sent this information. I am hoping this will encourage a family reunion over there in May 1989. I know Ann Nosov from Canada plans on a trip to Ireland then.

Well...once again the story doesn't stop here!!!

About 2 months ago, I received a 24 page booklet written in 1851 about Lough Fea estate in Ireland...[some of this info was written in this issue about Lough Fea]. It was sent by one of our members in England. Written on the front page is...

To the Rev P.W.N. Shirley in 1927 from R.G.S.K.

Now...what do you think of that??? What a co-incidence!!!

I looked up Ann Nosov's letter of Dec. 16th 1982 when she first wrote to me...

Dear Miss. Shirley,

My maiden name was Shirley and I was born in Ireland in a small isolated area of Counties Carlow and Kilkennythat was home to so many generations of Shirley families. All were farmers, and although tenant farmers as was the custom at the time, they seem to have been a hardworking, thrifty folk with fair sized land holdings.

I have traced my particular line to about 1800 but beyond that the records are so sketchy that I doubt if I will ever be able to fill it in.

Two quotes from different publications state..."In the county of Kilkenny there is a still existing family of Shirley, said to be descended from a certain William Shirley who accompanied King William III to Ireland and settled in county of Wexford".

From Stemmata Shirleiana by E.P. Shirley page 338 published 1841.

"There is no precise explanation of the motivation behind the post 1798 settlement of Protestant Wexfordians that settled on Coolcullen hill, and gave their name to "Protestant Road". They integrated widely because of the cures which the Marshall, Dalys, Griffins, Shirley Watchorns etc., practiced and which attracted hundreds until drugs took over in the 1950s."

Ann Nosov

Ann became a member of the National Shirley Assoc. in the USA. I advised her we would only be writing about the Shirleys of early America and their desc. She said she realized it but was

Interested in the name of Shirley. She even came to Williamsburg, Virginia in 1987 to our Shirley Convention to meet us.

In a letter from Ann dated Sept 22, 1988.. she was refering to the Shirleys in Ireland ......Fortunately, the Shirleys in Carlow and Kilkenny were farmers. They were tenant farmers as were all their neighbours. It wasn't till the end of the 1800's and the beginning of this century that they had the opportunity to buy their farms with the help of the Irish Land Commission and the break up of the big estates. The Shirleys had long leases and their farms with rights of renewal, and for some reason were most delegent in registering all these leases, sub-leases, agreements, etc. at the Registry of Deeds, Dublin, although it wasn't legally necessary to do so. The registry was set up in 1708, and everything registered there is in tact, and their search room is open to the public. Most of the early information I have on the Shirleys was obtained there.

The earliest document I have so far discovered, that places the Shirleys in Kilkenny, is a lease dated May 9, 1761, in which JOHN SHIRLEY of CROAN, leases 398 acres of the lands of Bellmount, Co. Kilkenny, from the Rev. Arthur Webb and his son Arthur Webb. Esq. This lease was renewed in 1764. In 1766, a lease was made whereby John Shirley of Croan leased the lands of Bellmount to THOMAS SHIRLEY. Now whether this John was Thomas' father, or brother, I don't know. More than likely John was the father. Why I say this is because the custom in Ireland at that time was to name the first born son after the paternal grandfather, and according to the postscript to the will, John of Knockabrannar was the eldest son of Thomas.

This 1766 lease was never registered, but it must have been an important one for the family, as I have six subsequent ones relating back to it, the last one dated 1893.

The Parish registers for Old Leighlin church were destroyed by fire, but a notebook survives which covers the years 1781-1811. I've enclosed these on a separate sheet of paper.

John was living in Belmont in 1794, according to one lease. On Jan 22, 1801, he leased 104 acres in Knockabrannar from Edward Groome, Esq. and this is where he and Deborah lived. (Knockabranner and Bellmont are about three miles apart). [Ann's uncle Billy lived in Knockabrannar in 1951].

No record has so far been found of when John was born, was married, or when he died. Deborah's tomebstone is in the Shirley plot in Old Leighlin church yard, and reads: "Erected by Sarah O'Neill of Ballinakil the memory of her belov mother Deborah Shirley of Knockabranna who dept. this life March 25th 1845 aged 72". Perhaps the reason John's name is not on the tombstone is because he is buried with his first wife (if he had a first wife) in some other Parish.

# 1836 WILL OF JOHN SHIRLEY OF IRELAND

The last will and Testament of John Shirley Knockabrannar in Parish of Old Leighlin drawn up at my request October the 6th of 1836.

I John Shirley being in perfect possession of all my faculties and now wishing to make a final settlement of all my earthly affairs do of my own free will and choice make the following divisions of all my porperty and wish that same should remain uncharged and binding on all concerned and I John Shirley do will and bequeath to my wife Deborah Shirley and my Son Abraham Shirley my farm which I now hold in Knockabrannar together with all my stock in cattle and all other property that may be thereon at my death to be equally possessed and held by same Deborah Shirley my wife and same Abraham Shirley my son, I further will that if my wife Deborah Shirley should at any further time wish to seperate or live distinct from same Abraham my son, that she Deborah Shirley be entitled to half of whatever stock and of all other property within and without, which at time of separation may exist. And also I will that she Deborah Shirley shall at such seperation be entitled to half of my present farm in Knockabrannar. I further will that after the death of my wife Deborah Shirley that all the stock and other property then existing together with the whole of my farm be the sole and property and possession of my son Abraham Shirley. I further will that my wife Deborah Shirley and my son Abraham Shirley pay conjointly the annual of four pounds to Catherine Shirley widow of my son Thomas Shirley, and that same sum of four pounds be paid to same Catherine Shirley during the existance of the present lease. I further will that my son Ansley Shirley and Catherine Shirley widow of my son Thomas Shirley should hold undisturbed their present farms in the same manner as they now hold and possess them. I further will and bequeath to my son Abraham Shirley the profit rent now arising from Kilfoyle's farm in Coon, being eight pounds ten shillings annually to be possessed by same Abraham Shirley during the continuance of same forever. I further will that Paul Shirley my son the present occupier of same farm in Coon is not to be distrubed from its possession by my son Abraham Shirley or any person representing him provided the annual interest of eight pounds ten shillings be paid regularly. I further will and bequeath to my son John

Shirley of Brackin the whole interest in and arrising from my farm near Mount Melick known by name of Bog Farm. I further will and bequeath to John Shirley son of Ansley Shirley the sum of twenty pounds to be paid by my son John Shirley out of the Bog Farm in four different and equal payments, six months intervening between each payment. I further will and bequeath to my son Ansley Shirley all the interest arising from the Gowrawn farm in Coon also known by the name of John Bradley's farm. I further will that when the interest of my son John Shirley shall cease in the Bog farm the life thereof having fallen, that same John Shirley shall have equal share with my son Ansley Shirley in the interest arising from the Gowrawn Alias Bradley farm in Coon, this only to commence its interest when interest in the Bog farm ceases. I further will and bequeath to my daughter Margaret wife of James Butler the sum of ten pounds to be paid same Margaret by my son Ansley Shirley at the experation of one year. from the day of my death. I further will and bequeath to me son James Shirley of Ridge the annual interest arising from the holdings of Martin Kealey, John Tales, Michael Conners and Patrick Walshe, to be possessed and enjoyed by same James Shirley as long as same interest continues. I further will that if my son Abraham Shirley now unmarried should take as wife a person who is member of the Church of Rome that no part of the property herein by me bequeathed to him shall be his. That such an act shall disentitle him to the possession of any part of my property and the property thus forfeited be equally divided between my sons Paul Shirley .-I john Shirley being in possession of all my faculties and understanding unipaired, and directing every and all distrubutions of property as herein expressed I sign this as my last will and testament.

Interesting Facts About SHIRLEY PLANTATION AND the CARTER & SHIRLEYS.

[from: Shirley's in Maryland and Virginia 1600's and 1700's by Betty Shirley].

The Shirley Plantation was established in 1613 by Lord Delaware West, son-in-law of Sir Thomas Sherley, the elder of Wiston in Sussex, England.

Colonel Edward Hill came into possession of the Shirley Plantation in 1660 and it remained in the Hill family until the third Edward Hill gave it to his daughter, Elizabeth, when she married John Carter, son of King Carter, and Shirley has remained in the Carter family since 1723.

Edward Hill I was granted 450 acres in Charles City County, Virginia for personal adventure and transportation of 8 people. He was commissioned in 1645 by Governor Berkeley to travel to Maryland and demand the return of certain Virginians who had taken up land illegally.

Apparently, Hill and Governor Calvert of Maryland had an agreement to protect Lord Baltimore's interest in the colony while the Governor hurried to Virginia on business. Hill was to be compensated for his services and Gov. Calvert signed a commission to Capt. Hill "deputing and appointing him Gov. of the Province of Maryland" in his absence.

Hill was not immediately compensated after his return to Virginia. He waited for his money which was slow in coming. Suddenly, Gov. Calvert died and the executor of his estate, Margaret Brent, settled the debt promptly.

In 1647, Edward Hill lived at Westover and by 1655, a deed for 60 acres of land in Charles City County refers to him as Edward Hill of Shirley Hundred. In 1660, Colonel Edward Hill patented 416 acres within the boundaries of Shirley Hundred, including the site on which the present mansion now stands.

Edward Hill II inherited the Shirley Plantation when his father died in 1663. Lord Culpeper stated he knew Edward Hill since his youth. Edward Hill II married Tabitha Custis, widow of General John Custis of Arlington, Virginia.

Edward Hill III inherited the Shirley Plantation when his father died in 1700. He married Elizabeth Williams. He had a cricket court on his lawn at Shirley where Governor Spotswood played cricket as well as other notables of the day.

Edward Hill III was the father of Elizabeth Hill who married John Carter, son of King Carter. Edward Hill gave Shirley Plantation to Elizabeth as a wedding present.

\*Charles Carter, son of Eliz. Hill and John Carter, was the father of 23 children. One of these children was Ann Carter born in 1773. She married Lightfoot Harry Lee.

Lee was a widower with several children. He was twice Ann Carter's age and her father was not much in favor of this romance.

Thomas Jefferson had offered an ambassadorship to Lee to France but Lee declined the appointment and this apparently smoothed the was to the marriage as the wedding took place at "Shirley".

Their fourth son was ROBERT E. LEE who was born January 19, 1807. He later became the —famous General Robert E. Lee.

The father of King Carter was John Carter who with his brother, Thomas Carter, emigrated to America about 1649 and settled in upper Norfolk County Virginia. (Thomas Carter married Katherine Dale, daughter of Edward Dale).

John Carter married 5 times, the fifth being to <u>Elizabeth Shirley</u>, a spinster of Gloucester Co. Virginia.

John Carter's fourth wife was the mother of King Carter. Thus, Elizabeth Shirley was the step mother of King Carter who's son married Eliz. Hill and they inherited Shirley Plantation!

Margaret Brent and her brother, Giles Brent came from England to Maryland in 1638. By 1651, they migrated to what is now known as Northumberland Co. Va. They had become weary of the bickerings of the Puritans of Maryland. They brought into Northumberland Co. many Marylanders upon whose headrights a great amount of land was granted, being more than 15,000 acres.

In Westmoreland Co. Va. 1660, Giles Brent signs as witness with Robert Sherley.

\*Charles Carter married Anne Butler Moore, daughter of Ann Catherine Spotswood and Colonel Bernard Moore. (Ann was the daughter of Governor Spotswood of Virginia). from Northumberland Co. order books...

Daniel is listed with 5 people in the district from Edmond's Hill to Princess Anne and Carolina lines as far as the Northwest River.

Could they be.....the sons of Daniel Shurley who died in Northumberland Co. in 1768?

Daniel Shurley of Norfolk Co. Va. was living in the adjoining county of Princess Anne as of 1814. His will reveals he still owned a large tract of land in Norfolk Co. Va.

THIS DANIEL SHURLEY WAS THE GREAT GRANDFATHER OF O. HENRY.
