HISTORIC OBEDIAH HUGH SHIRLEY HOME ACQUIRED BY SHIRLEY ASSOCIATION !

It is now within the realm of possibility for that headline to become a reality. Our Association has a rare opportunity to <u>save from destruction</u>, and restore a Shirley ancestral dewelling. The home of Obediah and Jennie Armstrong Shirley is sceduled for demolition soon, <u>unless</u>, we act swiftly. An 18 acre tract, including the home, has been sold to Langston Real Estate Company of

Honea Path, South Carolina for development as a retirement community.

First, a bit of history. Obediah Hugh was the son of John and Elizabeth Burton Fields Shirley and was born in Abbeville, S.C. August 29,1804, married Jennie Armstrong (b. Jan. 19, 1807), March 18, 1824. He died February 18, 1889.

Obediah and Jennie built their two story home

one half mile west of Honea Path on land acquired from Jennie's parents, John and Isabella Bryson Armstrong, who received a royal grant on March 2, 1764.

One end is hewn logs. Door hinges, as well as some nails, are hand wrought by an expert blacksmith. The two chimneys were built by David Moore of rock - some four feet long, sixteen inces thick - from a nearby quarry owned by the Armstrongs.

Their ten children- John Jasper, James Marion, Nathaniel, Amaziah, Isabella, Benjamin Franklin, Archibald Pinckney, Martha Jane, Elizabeth Frances, William Marshall and an unnamed baby who died at birth, were born in this home.

No one can question its extreme importance to Shirleys, as well its general historical value.

My first visit to the home was Monday April 13, 1987 in connection with a long planned pilgrimage to search my S.C. roots. What a thrill to finally see the home my great- great- grand-parents built. I felt I was standing on Holy Ground. Nevertheless I was depressed by the home's delapidated condition. No repairs have been made in years and the house has been rented out.

My depression deepened the following day when I learned of the imminent destruction of the home. After a sleepless night, I advised Bill and Sue Henderson of Beaufort, S.C., (I met Sue an Obediah descendent, on our England tour last year) of my decision to give the saving of Obediah's home my "Best Shot".

I subsequently met with Tom Langston who, I learned, shares my love of history and family. I expressed my distress at the prospect of the destruction of such an important land mark— not only to the Shirleys, but the entire area (preliminary research reveals it may well be Anderson County's oldest home). As a result, he generously offered a gift of Obediah's home, plus one acre, to the Shirley Association, provided we commit to the restoration and upkeep of the property. Restoration will be expensive, but can be done in stages. Immediate needs are:

- general clean-up
- 2. roof
- 3. replace broken window panes

- 4. door locks
- 5. possible termite treatment
- 6. fence property for security
- 7. insurance and taxes

Also costs in connection with the establishment of a Tax Exempt Shirley Foundation, making Tom Langston's gift to us as well as our gifts for restoration, <u>tax free</u>!

Plans for restoration to be done under the direction of Mr. Hurley E. Badders, Executive Director, Pendleton District Historical Commission, to meet guidelines in out attempt to qualify for listing in the National Register (what an honor that would be).

Mr. Langston has made a firm offer. NOW! the Shirley Association has a most important decision to make- accept or reject his generousity.

Financial support is needed <u>immediately</u>. If sufficient funds are received, the Assoc. will proceed with the signing of documents setting up the Shirley Foundation, contracting for restoration, etc. <u>IF</u> sufficient funds are not received, the project must be abandoned. The decision is yours!

THANK YOU SHIRLEY! I would like to add, if this can be carried out and we can be made tax exempt, other projects could be considered in the future. We have been contacted by a couple of villages about repairs to their churches in England where Shirleys were members. In both cases, they only needed a couple thousand of dollars to repair stones etc. falling from around window s etc. To much of an expense for the village or the church. Who knows what the future holds!

A Shirley Museum would be nice too! and in the heart of Shirley land...Abbeville area S.C.

Tabitha Sherley last appears on the 1788 list.

The John Ambrose Shirley b. 1770 is first found by this family's researchers in Mason Co. Ky on the 1799 tax list.

Is this their Shirley ancestory listed above? Could Ambrose father, be Ambrose?

This appears to be John Shirley, son of Daniel.

In the special Tax list of Virginia 1782-1787, John and Daniel Shirley are listed in Norfolk Co. Va.

Daniel is listed with 5 people in the district from Edmond's Hill to Princess Anne and Carolina lines as far as the Northwest River.

Could they be.....the sons of Daniel Shurley who died in Northumberland Co. in 1768?

Daniel Shurley of Norfolk Co. Va. was living in the adjoining county of Princess Anne as of 1814. His will reveals he still owned a large tract of land in Norfolk Co. Va.

Argeland Sherley, Executor.

At a court held for Northumberland Co. the 11th of April 1748. This account of Adm. of the estate of John Sharley dec'd was returned and by the court ordered to be recorded.

Note the many ways the name Shirley is spelled in these records for the same family or even for the same person.

EDITORS COMMENTS: I would like to know who is George Shirley? He is mentioned in the administration papers of Daniel Shurley and I have seen his name on other papers...not all given here. He is not listed as a son of Daniel. He is also not listed as a brother of Daniel.

In 1699, George Shirley was a surveyor and in 1702 he was a sherriff and J.P. Could George be a brother to John who was born about 1671 and died in 1738, father of Daniel? George Sr. & George Jr.?

Another of the name George appears in Prince William Co. Va. as early as 1783 and is there until at least 1790 era.

A Thomas Shirley was Sheriff in 1707 in Northumberland Co. Va. This is no doubt the son of Thomas Shirley. He was born Oct. 22, 1666 St. Stephens Parish.

So...we have in Northumberland Co. Va. in those earliest of dates:

Is he a son also and not mentioned in the records? They could have been born before coming to St. Stephens Parish, Northumberland or?

Our researcher says she is sure that the Shirleys of Prince William Co. Va. are the ones from Northumberland Co. Va.

We do have a good researcher in Pr. Wm. Co. now and she is very busy helping with good research. I should also add she will be working in Fauquier and other counties. We had the pleasure of meeting her, listening to her, and she was very kind to accompany us on our bus as we visited the former sites of the Shirley land. She gave me the map with the properties identified and I shall add this in this issue of the NEWS. She will now begin trying connect families.

From editor...It sure took along time to settle and record John Shirley, Jr. estate. He died in 1742. The child his wife was expecting at the time of his death was Winifred. In 1766, this daughter Winifred would be about 24 years old!

REPORT ON CONVENTION AND HISTORICAL TOUR

CONVENTION

Estimated 100 people attended the 1987 Shirley Convention in Williamsburg, Virginia on the week-end of June 20-21.

My sister-in-law, Evelyn, and myself left the San Jose, Ca. airport early (7:16 am) on Tuesday, June 16th and arrived at the Norfolk Va. airport about 4:49 pm. with a change of planes in Chicago mid-day. I picked up my luggage and we waited and waited and no luggage for Evelyn. Well... you guessed it...it never made the plane at Chicago. They traced it immediately and said it would be there on the next flight. So, I went to rent the Van and after some problems there, finally got it arranged and back to the luggage area for its arrival. The plane was late and about 7:00 pm it arrived and at last we were on our way to find Williamsburg and the hotel.

Out I went to the parking lot to locate the van. (They did not bring it curbside for me nor did anyone take me to it). I have never driven a van and this is a 15 passenger van! I climbed in and wished I was driving my little Honda Prelude. I was scarred to death. It was parked in a small area and I thought I would hit the car parked along side. I reluctantly pulled around to pick up Evelyn and the luggage. NERVOUS??? isn't the word for it. I didn't think I could handle it but knew I had to! We took a slow route to William sburg and didn't get there until after 11:00 PM and it is only one hour drive. We did stop to grab a hamburger though. This van was all over the road. It had been wrecked and was out of alignment. I tried the next day to get another but no luck. I was stuck with this van for the entire week.

On Wed. I picked up passengers at the Norfolk airport and on Thurs. we visited Jamestown and the area. These people were the ones coming early so they could see the area before the convention. Because there appears to be no tour services to these areas and to save them from renting cars etc. I offered to do this so those who didn't have transportation wouldn't miss the sites. We had a great time!

On Friday, I made two trips to Norfolk airport and one trip to Richmond airport (one hour the opposite direction from Williamsburg). I returned from my last run about 10 mintues late for the pre-

convention get to gether. Thank goodness I had asked a couple of people to be there to welcome those arriving on Friday eve. Gerald Finn, this years convention host, welcomed everyone to Williamsburg, Va.-- Gerald Finn is a Shirley descendant and has been active in the Colonial Williamsburg development for many years.

The morning was spent in talking about the Shirleys of colonial times and other prominent citizens of the era who lived nearby or inter-related to the Shirleys.

After the coffee break, those attending had a chance to stand and tell about their Shirley ancestors. After lunch, the meeting turned to the Shirley ancestory in England. After the afternoon break and dinner, we returned for the viewing of the Shirley Celebration video taken at Ettington last year in England.

Sunday, we met at 9:00 and went by caraven, those in there own cars, us in the van, to Shirley Plantation about an hours drive. We divided into two groups. The first group went to the yacht club to board the boat for a river cruise. After their return, the second group went. What a view, seeing Shirley Plantation from the river. I tried to imagine that this was the way of transportation in those days. Not the roads. Imagine Lord Delaware West arriving at Shirley by river! This is the scene he viewed...but without this house that stands on it now.

Lunch was served buffet style and catered for the Shirleys at Shirley Plantation. The Shirley Coat of Arms was frozen in an ice carving, a cake was decorated with the Shirley Coat of arms. After lunch we toured the Shirley house and the grounds. Later, we had a watermelon feed under the big tree. It was just about this time that it grew dark with rain clouds and the wind started blowing. We just finished and left when the

rain began to come in sprinkles. We didn't get wet. The sun had been shining and it was a great day.

We had music entertainment, sang songs to our fathers who were attending...This was Father's Day! & wished Capt. John and Evelyn Shirley a Happy Anniversary. We had a great time of fellowship with the family!

Monday morning and it was time to say our..."goodbyes" to those who were not going on with us on our Historical Tour.

The gang loaded in the bus for the Norfolk airport and took a plane to Boston, Mass. Here we were met by another bus and we toured Boston for alittle while and then to Kings Chapel where Governor William Shirley is buried. The Curator who has Mondays off and the Chapel is closed, came down to let us visit at my request..some months ago. This was the only day we could visit Kings Chapel. From there, we were taken to our hotel where we checked in, changed and in alittle while we were back on the bus headed for Governor William Shirleys mansion for dinner.

What a lovely experience visiting this fine old home. An escorted tour of the house, a catered dinner, musical entertainment and a chance to meet more Shirleys who met us here.

We learned that \$250,000 has spent so far on the refurbishing of Shirley mansion. If anyone would like to be a member of their Association, I will give this information below. They would be pleased to have some Shirleys as members of their Association and to help with their expenses as they strive to preserve the Shirley mansion.

On Tuesday, we visited Plimouth Colony and the Mayflower, both being replicas of the orginals. The afternoon was spent in New Hampshire visiting the farm at SHIRLEY HILL, home of 6 generations of Shirley who came here from Ireland in 1730 and settled in the Chester area of New Hampshire. We were greeted by Mary Shirley who lives there now. Her husband, Larry, passed away last year. I couldn't help but think about what he would think about all of us here visiting his home.

We enjoyed our visit with Mary and the lovely tea time. Her nephew, Robert and his wife Althea Shirley, came up from Mass. to be with us here in addition to being with us at Gov. Shirleys the evening before. We also met a few other Shirleys, some members of the Assoc living within driving time from Shirley Hill. We returned to Boston that evening and dined at Pier 4 on Boston Harbor, then to the hotel. Next morning we checked out and journeyed to New York. That evening attended a Broadway play "The Nerd" with Mark Hamill, and following that, we went to the Empire State Building and went to the top! It was so peaceful up there...after 10:30 at night. What a view!!!

Next day it was a Ferry ride to the State of Liberty and after lunch, we departed New York for Washington's Crossing on the Delaware. We dined in a very relaxed environment right across the road from this historical place. The food was good! Such a change of pace from the hurry and people of New York! This was out in the country.

We arrived that night at Philadelphia, Pa. and checked into our hotel. The next day we left on a tour of Philadelphia and Valley Forge. For dinner, a river cruise dinner on the Delaware River from 7:00 pm to 10:00pm. What a great time everyone had relaxing and seeing the sights along the river.
