From researcher...notes: Until 1755, when the Fairfax county line was moved to where it still is today, (boundary between Rockingham and Shenandoah counties) the Augusta County line extended up to where Woodstock is in Shenandoah County.

The only reference to Nicholas Shirley is what can be found in Chalkley.

Felty is the nickname of Valentine, and is usually associated with German background. Valentine Shirley did marry a Baer who was of German background through both the Baer and Adam Miller.

VALENTINE b. mid 1700's in Pennsylvania, as known from the 1880 census when his daughter Elizabeth recorded her fathers state of birth.

It is not known when Valentine came to Virginia. He married Catherine Baer ca. 1770.

All except John (who went to Tennessesse), were early settlers in Indiana. Charles later went to Illinois and Adam to Miss.

Valentine served as an ensign in the American Revolution and was a prosperous farmer in Augusta and Rockingham Counties in the Shenandoah Valley of Virginia. He died in 1811 in Virginia.

PETER b. mid 1700's wife, unknown.

Researchers suggest Peter was probably born in Pennsylvania but was resident in Maryland by 1773 when Christian was born.

He was later recorded as a miller in Washington Co. Maryland in Dec 1785. Later he moved to Augusta Co. Va. where on May 26, 1795 he was ordered to repay

he was ordered to repay 28 pounds he had borrowed in Washington Co. Md. in 1785 plus 5 pounds for damages.

In 1797 a suit was filed by John Canote, Jr., against Peter about the ownership of a bay mare. The depositions in this suit show some of the family of Peter; son Christian who was "lately married to a daughter of John Canote Sr."; son Balser; daughter Mary (Polly) of age. Also deposing were Sally Argenbright and a Henry Harmon (of age) who was living at Peter's house (file 458). The report of this suit in Chalkley Vol. 1 p. 412, says that Sally, Henry and Christian were about to remove to Kentucky; The final judgement in the suit was in favor of Peter.

**In 1799 Peter bought land in
Madison Co. Ky. (Book D p. 629)
which he sold in 1801 to his son
Jonathon and wife Nancy, who in
turn sold to James Runkle. Peter
and his son Christian are recorded
in the 1800 census of Madison Co.

Peter is in tax lists of 1806 and 1809 of Jessamine Co. Ky (next to Madison Co.) He appears in a tax list of Harrison Co. Ind. in 1813. His son Christian was also living there.

On Aug. 25, 1841, Jonathon authorized payment to Jacob Shurley of money from a sale of Peter's land.

**Aug. of 1799 Christian bought land from William McGuire and his wife Mary (daughter of Michael Shirley and Katy Franz).

Valentines family can found in the Jan. 1983 NEWS p. 7 & 8. Peter can be found in the NEWS of Oct. 1983 p. 12.

MICHAEL b. ca. 1740 prob. Pa. m. Catherine "Katy" Franz

Michael served in the Revolutionary War 1777-1779. He was stationed at Fort Washington. When he finished his stint at the Fort, they returned to Pennsylvania. From there they migrated to Augusta Co. Va. where he was a surveyor. They moved on to Kentucky about 1780. In 1784, Michael was killed by Indians while surveying in Old Lincoln Co. Ky. (now known as Madison Co.).

In 1800 census, Katy, his widow, is listed in Madison Co. Ky.

<u>PATRICK</u> b. ca. 1720 d. ca. 1783 Botetourt Co. Va. He married Anna

Patrick served in the Revolution-ary War.

By 1744, Patrick was dealing in land with Col. James Pattan. In 1746 he owned 400 acres from a new grant at "Locust Bottom" By 1773 Patrick and Anne 1,389 acres in Botetourt Co. Va.

Patrick established a milling business on the Upper James River in 1746. In 1776 Patrick furnished horses for an expedition against the Cherokees for the Battle of Long Island in the River Holston. In 1783 he furnished thirteen horses and seventeen cattle and one slave.

Mary Sharley m. Joseph Moore in 1794 in Clark Co. Ky. He was the son of George and Eliz. Moore from Conewego Pennsylvania. George Moore is mentioned in Richard Shirleys estate settlement in Scott Co. Kentucky in 1796, See Shirley NEWS April 1984 page 12.

Consent for Mary to marry Joseph Moore was singed by Adam Sharley. There was an Adam mentioned in Augusta Co. Va. between 1742 & 1800. Valentine had a son Adam but would not be of age in 1800 or earlier.

Please review the McGuires written in the January 1983 Shirley NEWS on page 9 and 10. They came from Conewgo Valley of Pennsylvania. This family was connected to the Shirleys of Bedford Co. Pennsylvania and one of these Shirleys, William, came to Scott Co. Ky. in late 1700's and his will is recor ded there in 1805. Remember the Mcguires are married into the Michael Shirley branch. Was it the same McGuires Gamily???

FROM YOU EDITOR:

I have tried to give you just enough background on the various Shirley branches that came thru Augusta Co. Virginia so that you may understand some of the research results to be reported in this issue of the NEWS.

This will be of some help to our more recent members who do not have all of the back issues of the NEWS. (They are available in book form for \$55...40 back issues).

ANOTHER AUGUSTA CO. SHIRLEY FAMILY

An old family Bible belonging to a Shirley family, records the name of Richard Charles Sherley, 1817, Jones Co. Georgia on the front leaf.

This branch of Shirleys were in Augusta Co. Virginia according to their family tradition and records.

Edmund, John, Richard, James and William Sherley were brothers and came to Virginia in the early part of 1700. They settled in Augusta County, Va., became dissatisfied, separated, one going to Kentucky, another to South Carolina. Later James, John, Edmund and William settled in Georgia, in the year 1775.

According to Updike ...

William Stubley Shirley, Sr.
was born about 1732 Ireland and
came to Augusta Co. Va. with
brothers Edward, James, John and
Richard. They settled in Georgia
about 1775, William then had a
wife and 5 children. He served as
a private in Georgia troops in the
Revolution and was granted 250
acres of land at the Fordof McBeans
Swamp and 140 acres at Chicasaw Old
Path, 200 acres each in the Parish
of St. Paul and St. George, in
Georgia.

Please find some recent research results from Augusta Co. Va. (as sent to me by our researcher we hired some months ago), on the following page. If you study carefully, you can begin to see a tie to some of the families in Ky. etc. and a possible tie to Pennsylvania.

AUGUSTA COUNTY VIRGINIA RESEARCH RESULTS

Aug 19, 1777 Felty Shirley recommended for ensign. (Felty was a nickname for Valentine).

Feb 17, 1778 Valentine was commissioned ensign in the militia.

Aug 18, 1778 Valentine and Jacob Barrier appointed road surveyors.

Nov 16, 1779 Grand jury presentments against Valentine and 43 others for retailing without a license.

Sept 24, 1791 Valentine surety for his daughter, Barbara who married Samuel Baker.

In 1793 Valentine <u>Softley</u> was a petitioner for a road in Rockingham Co. that would pass through his land and other lands including those of Samuel Baker.

June 29, 1793 Slander suit by Gasper Mefford Jr. against Valentine Sherley. Recorded April 1795.

Aug 12, 1793 "Jacob Shearley, infant, by Valentine Sherley, next friend, vs. George Mefford".

Nov 6, 1794 Valentine an appraiser of estate of Jacob Barrier.

April 6, 1794 Valentine Sherley surety for (marriage license of) Henry Spearing, widower, and Jane Price, widow.

Catherine Shirley, widow of Valentine, Jacob Shirley and his wife Sally, Adam, Elizabeth and Anna Shirley, all of Augusta County Virgin ia. George Cook and Nancy his wife, late Nancy Shirley, of Rockingham Co. Va., John Shirley and Ann his wife of Grainger Co. Tennessee, Samuel Baker and Barbara his wife, late Shirley, Henry and Catherine his wife, Charles Shirley and his wife Sally, all of Washington County Indiana Territory.

Michael Shirey of Jennings Gap, 87 yrs. old, was a native of Pennsylvania but has been a resident of Augusta Co. Va. upwards of fifty years.

A cemetary record of Michael Shirley in St. Peter's Lutheran Cemetary, Churchville, Virginia. This in the immediate area of Augusta Co. Va. where Jonathon Shirley lived. [Jonathon Shirley was the son of Peter].

Michael was born May 1755 and died January 1842. (a native of Pennsylvania).

In the list of Loyal Land Company purchasers, Loyal Company vs. French, page 43, Michael Shirley purchased 527 acres. This list does not give location or date, but all Loyal Company land was in southwest Virginia in the area embraced by both Botetourt and Monroe County.

There are many other items on deeds etc. all relating to the named Shirleys and would be a duplicate of material. I shall refrain at this time from detailing and report only material showing a new connection or name etc.

From... Augusta Historical Bulletin Vol #17 Spring 1981 #1.....

On the 5th instant, near Churchville, Esther Shurley, wife of Jonathan Shurley, aged 65 years, 7 months and 2 days. (March 9, 1853).

from...Staunton Spectator, Jan. 14, 1841 Died on the 6th inst., of a bilous attack, Peter Shurley, of the North mountain, in this county. (AUGUSTA CO.)

Ibid., April 19, 1841 Died on the 18th inst., at the residence of his father, John, son of Jonathon Shirley, in the 30th year of his age... a member of the Methodist Episcopal Church.

from researcher...notes:

She feels the antecedents of the Shirley family are going to be found in Pennsy-lvania. Apparently, Peter Shirley stopped in Maryland for awhile. There were commissions from Augusta Co. that were directed to FranklinCounty, Penn. in one of the judgements.

Isaac Scooly appears on an adminstrator's bond and the names on this bond indicate he lived in the area of Augusta Co. that became Bath County in 1791.

The judgments in Chalkley, Vol 1 reguard to Peter, finds the name spelled Shelly, Shally & Shirley in the papers.

There is no will for John Canote, Sr., Peters' in-laws...After he purchased the land in 1791 from the Bradshaws, he sold it on March 31, 1802 to Michael Shirey.

There has been several ways the name has been spelled in the records. SHALLY SHELLY SCHALLY ETC. We have in most cases looked at Shirley, Sherley, Shurley, Sharley etc....

[Printed in the Apr. 1979 NEWS].

1751-52 Petition of inhabitants of the north side of the South River of Shenandoah for a road. About 3 years ago it was ordered to open a road from Caleb Jobs plantation down the south side of the said North River to James McCoy's plantation, which road is not suitable, and prepare a location on north side crossing the river at place called the Brush Bottom Ford and along the river by Henry Speer's plantation. Among those who pray for survey are Richard Shirley and Thomas Grubs.

A bill binding Ralph Hughes and <u>Richard Sherley</u>, (both of Augusta Co.) to pay or cause etc., unto Mathias Celzar, etc. March 17, 1750-51. Test, Peter <u>Sholl</u>, Samuel Newman.

Aug. 21, 1767 Surveyors of highways appointed <u>Patrick</u> Shirley and William Watkins from James Montgomery's at Catawho to side of Craig's Creek Mt. where John Potts quit clearing.

March 23, 1769 Felix Gilbert and Michael Shirley appointed surveyors of the road from Jacob Nicholas' to Hance Magots.

William Shurley listed in Chalkley also lived in that part which ended up in Frederick County until 1772 when it became Shenandoah County.

In the household of Peter Shirley in 1797 when Peter was involved with a law suit, was Sally Argenbright. Valentine Shirleys wife, Ann Baer had a sister who married George Argenbright and they had a daughter Sally. It has been stated this is the same Sally.

Michael Shirley who married Katy Franz had a son George Shirley who was father of Charles David b. 1806 Ky. who was the father of George A.T. Shirley. His wife was Cornelia Ann Baer and it has been stated she is the niece of Valentine and his wife, Catherine Baer.

This concludes the items on Augusta Co. Va. Although there are many other items they are about the same people and misc. records. There does not appear to be any other Shirley families but those mentioned unless their name is spelled very differently.

GEORGE SHIRLEY OF AUGUSTA CO. VA.

A story written by Violet Buntain (sent by our researcher)

George Shirley was born Nov. 23, 1816 in Augusta Co. Va. He was the son of Jonathon and Esther Swope Shirley. Jonathon was the son of Peter.

George married first, Susan Hanger and second, Margaret James.

George Shirley left Virginia for Indiana in 1856.

He was a blacksmith in his native state but sold most of his belonging when he made the long trek north to the banks of the Wabash nearly a century ago.

He settled in Vermillion County and in 1871 built the homestead where the Buntain family still lives. He continued his smithy career in Indiana and only this year have the last traces of his blacksmith shop gone when Mrs. Buntain planted a garden on the site where his smithy stood.

On Feb. 1, 1865 Mr. Shirley held a public sale at his home in Shenandoah Valley section of Virginia and meticulously noted down the prices brought for his various articles, Still intact in the Spencerian script favored in those days the Shirley accounts contain some extremely interesting bits of historic oddities.

For instance if you had been a Virginia farmer anxious to add to your herd of cows, you could have purchased a cow with a bee for \$15 and another cow with a white face for the same amount. Pigs, sure, two first choice pigs brought \$3.10 each while two more, not so choice, brought \$2.65 each. Shirley sold his bay horse for the big sum of \$10. And a bale of hay to feed the horse for \$1.00.

Seventy-five cents bought a wheelbarrow while two chisels went for 38 cents. A wooden rake sold for six and a quarter cents while a draw knife was sold for six and a half cents. A hand ax went for 62 and a half cents, a churn sold for 25 cents and a cook stove for \$8.87.

Even then men were at a loss to describe some articles around the house and these were tagged as "do-do's" but somehow they (or it) brought 30 cents. A coffee mill and box were worth 49 cents to some housewife while she also bought a meal sifter for eight cents.

One intriguing item in the list was labelled "box and contents" 36 cents. A crock of apple butter was sold for 50 cents; a child's craddle for 12 cents; a clock for \$1.47; three pictures, 8 cents, fox trap for 31 cents and a Spanish saddle for 50 cents and smoothing irons for 50 cents.

Shirley, his wife and nine children made the journey safely to Indiana and added two more members to the Shirley clan after they arrived. The only tragic note in the move of this Virginia family to Indiana was when Shirley's father decided to join his son in Hoosierland. He made his way to Indiana but at a fording place in the Wabash only eight miles from his son's home he slipped from the tongue of his wagon, fell into the river and was drowned.

Many descendants of the Shirley family still live in Vermillion County, making up one of the many families of pioneer settlers in this area.

WOULD THIS NOT LEAD YOU TO BELIEVE THE FATHER OF JAMES SHIRLEY WHO MARRIED JUDITH GARRIOTTWAS JAMES SHIRLEY?

There was an older James living in the same county as James who married Judith Garriott.

RICHARD SHIRLEY OF PRINCE WILLIAM COUNTY VIRGINIA MARRIED MARY GRAHAM

Their daughter...name not known!
married Wayman Sinkler/Sinclair/St.Clair
Wayman was born ca. 1708-14. His will
was written April 12, 1762 Loudoun Co. Va.

Wayman Sr. married 2nd, Hester Smallwood There were no children.

By the estimated birth years of Wayman's documented children, we can safely assume he married before 1740. In that year, he and his brother, Robert, are listed as tithers in Prince William Co. Va., the site of the homeplace. We do not know the given name of Wayman's wife; only that she was the daughter of Richard and Mary (Graham) Shirley.

It is certain that all of Wayman's children were born on his half of the homeplace in Pr. Wm. C. and apparently he and his wife led an uneventful life as only tax records on the homeplace appear until Nov. 19, 1760. On this date we find a detailed marriage contract recorded in Loudoun Co. Va. which states that Wayman and Hester are to marry and that her estate is to remain hers forever and his is to be held solely for his children.

When Wayman Sr. wrote his will he stated his youngest child was eight years old. His will was proved July 13, 1762.

The court ordered that the Executors of Wayman Sinkler, dec'd deliver the testors children to Mary Shirley their grandmother who engages to maintain and bring them up without any burden to their estate.

Mary Shirley is last listed in the tax records of Loudoun Co. Va. in 1763.

In 1782 the Sinclair brothers appear on the property rent rolls of Bedford Co. Va. Isaac is recorded in Wayne Co. Ky in 1810 and his son Isaac, Jr. is recorded in Breckenridge Co. Ky in 1820 and some of the Sinclair family moved to Putnam Co. Indiana.

According to family stories, my great grandmother, Penelope Shirley was born in S.C. between 1825-29; married Joseph Madison Morgan in 1840's. He was 13 years older than her. About 1854 came to Arkansas where Joseph Morgan Sr. was killed while piloting a wagon train in Northwest Arkansas. In May of 1857 Penelope married the widower James Long in Saline Co. Ark. There was much trouble in Saline Co. during the Civil War and by end of the war James Long

was planning to move away but became ill and died of pneumonia in July 1866 in Saline Co. Ark.

The next news of the family is 1870 census record of Pulaski Co. Ark. (Lonoke C . after 1873) where widow Penelope Long is living with her children in Caroline Twp. About 1874, her son Joseph Morgan married Sabra Bearden and moved to Texas, coming first thru Kennedale, Texas, then on to Motague Co. where he stayed a year or so, then settled at Vashti in Clay Co. where he had a large family and lived for many years. He finally moved to Wichita Falls where he died in 1926. It is not known whether Penelope and the young girls came at first or not but they did come, then, or soon after. By 1880, the daughter Sytha Francis had married H.V. Smith and was living in Kennedale and her sister Mary Letha was living with her. In 1882the daughter Virginia married Sam Duncan in Mansfield, Texas near Kennedale. They lived most of their lives in Stephens Co. Oklahoma. According to the story, Penelope became ill and died somewhere besides Vasti and was taken to Montague, either county or townm to be buried about 1878-77. There is no monument.

Shirley, widow and relict of Ambrose Shirley of Norfolk, and heir of Robert Tompkins and Christopher Tompkins, dec'd., being granddaughter of the former, and only surviving child of the latter, now residing in the Borough of Norfolk Virginia, nominates and appoints her friend Robert Brough of the same place as her true and lawful attorney in fact, to ask, demand, sue for, recover, and receive all rents, arrears, damages or claims now due or which may hereafter become due on her lands in Kentucky, and to sell and convey the same, to settle disputes, and to do all matters relative. July 1, 1817, and recorded by the Kentucky Court of Appeals, August 15, 1817.
